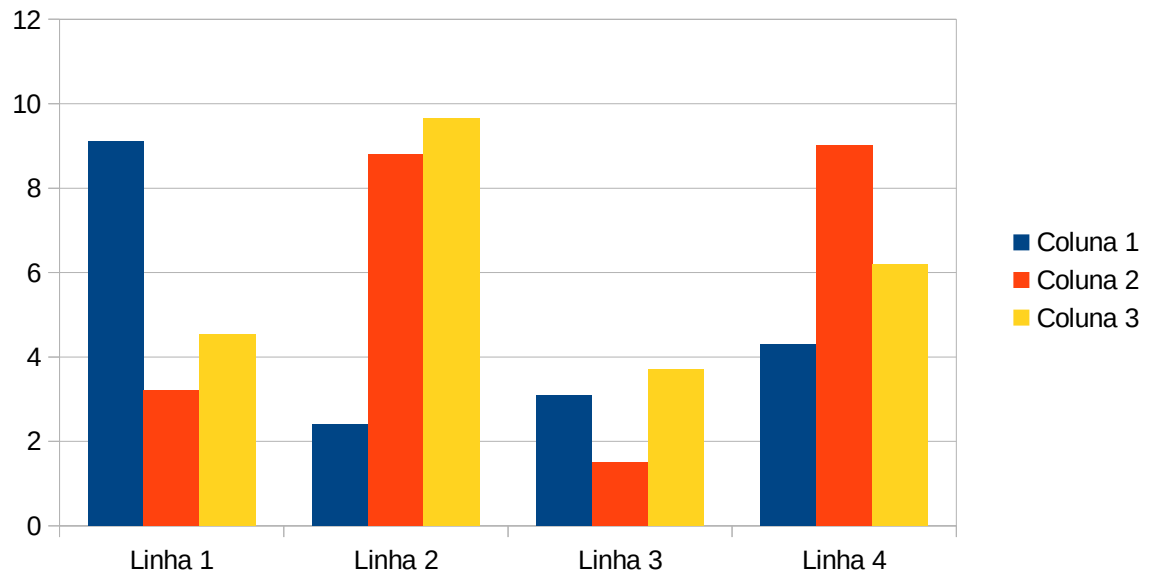


Figure 1: An analysis of the demands for the 21st century.
