# Geometry of the Ellipse and the Ellipsoid

#### Abstract

It is a chapter that concerns the geometry of the ellipse and the ellipsoid of revolution. We give the formulas of the 2D plane coordinates and the 3D Cartesian coordinates $(X, Y, Z)$ in function of the geodetic coordinates $(\varphi, \lambda, h e)$. A section is devoted to the geodesic lines of the ellipsoid of revolution. We give the proofs of the differential equations of the geodesic lines and their integration.

## Geometry of The Ellipse and The Ellipsoid

### 1.1 GEOMETRY OF THE ELLIPSE

### 1.1.1 Definitions

Definition 1.1 The ellipse is the locus of the points whose sum of the distances to two distinct fixed points (foci) is constant:

$$
\begin{equation*}
M F+M F^{\prime}=\text { constant }=2 a \tag{1.1}
\end{equation*}
$$

where $a$ is called the semi-major axis of the ellipse (Fig. 1.1).

Definition 1.2 An ellipse is the transform by affinity of a circle in the ratio $b / a$ where $b$ is the semi-minor axis (Fig. 1.2).

To the point $M^{\prime} \in$ circle $\Longrightarrow M \in$ ellipse with :

$$
\begin{equation*}
H M=\frac{b}{a} H M^{\prime} \tag{1.2}
\end{equation*}
$$

Let $\psi$ be the angle $\widehat{H O M^{\prime}}, \psi$ is called the parametric latitude or reduced latitude, then the coordinates of $M^{\prime}$ :

$$
\begin{array}{r}
x=O H=O M^{\prime} \cos \psi \\
y=O L=O M^{\prime} \sin \psi
\end{array}
$$

Hence, the coordinates of $M$ on the ellipse are:

$$
\left\{\begin{array}{l}
x=O H=a \cos \psi  \tag{1.3}\\
y=O L=\frac{b}{a} H M^{\prime}=\frac{b}{a} a \sin \psi=b \sin \psi
\end{array}\right.
$$

In the system of axes $O x, O y$, the equation of the ellipse is written:

$$
\frac{x^{2}}{a^{2}}+\frac{y^{2}}{b^{2}}=1
$$

We call respectively the flattening, the square of the first eccentricity and the square of the second eccentricity the quantities:

$$
\begin{equation*}
\alpha=\frac{a-b}{a}, \quad e^{2}=\frac{a^{2}-b^{2}}{a^{2}}, \quad e^{12}=\frac{a^{2}-b^{2}}{b^{2}} \tag{1.4}
\end{equation*}
$$

### 1.2 Parametric Equations of An Ellipse

The equations (1.3) represent the parametric equations of an ellipse in function of the latitude $\psi$. We will express these equations as a function of the angle $\varphi$ of the normal at $M$ with the axis $O x$.

Let $T M^{\prime}$ be the tangent at $M^{\prime}$ on the circle of radius $a$, the point $T$ is the intersection of this tangent with the axis $O x$. The transform of this tangent by affinity of ratio $b / a$ of this tangent is the line tangent to the ellipse at the point $M$ and it goes through $T$ (Fig. $\mathbf{1 . 3}$ ).

In the triangle $M H T$, we have:

$$
\operatorname{tg} \varphi=\frac{H T}{M H}
$$

and in the triangle $M^{\prime} H T$ :

$$
\operatorname{tg} \psi=\frac{H T}{M^{\prime} H}
$$

so :

$$
\frac{\operatorname{tg} \psi}{\operatorname{tg} \varphi}=\frac{H T}{M^{\prime} H} \frac{M H}{H T}=\frac{M H}{M^{\prime} H}=\text { ratio of the affinity }=\frac{b}{a}
$$

It follows:

$$
\begin{equation*}
\operatorname{tg} \psi=\frac{b}{a} \operatorname{tg} \varphi \tag{1.5}
\end{equation*}
$$

From (1.5), we write $\cos \psi$ and $\sin \psi$ in function of the angle $\varphi$, then:

$$
\frac{1}{\cos ^{2} \psi}=1+\operatorname{tg}^{2} \psi=1+(b / a)^{2} \operatorname{tg}^{2} \varphi=\frac{a^{2} \cos ^{2} \varphi+b^{2} \sin ^{2} \varphi}{a^{2} \cos ^{2} \varphi}
$$

and :

$$
\cos ^{2} \psi=\frac{a^{2} \cos ^{2} \varphi}{a^{2} \cos ^{2} \varphi+b^{2} \sin ^{2} \varphi}
$$

Let:

$$
\begin{equation*}
W^{2}=\frac{a^{2} \cos ^{2} \varphi+b^{2} \sin ^{2} \varphi}{a^{2}}=1-e^{2} \sin ^{2} \varphi \tag{1.6}
\end{equation*}
$$

then:

$$
\begin{equation*}
W=\frac{\cos \varphi}{\cos \psi} \tag{1.7}
\end{equation*}
$$

We calculate in the same way $\sin \psi$ :

$$
\sin ^{2} \psi=1-\cos ^{2} \psi=1-\frac{a^{2} \cos ^{2} \varphi}{a^{2} \cos ^{2} \varphi+b^{2} \sin ^{2} \varphi}
$$

we obtain:

$$
\begin{equation*}
\sin ^{2} \psi=\frac{b^{2} \sin ^{2} \varphi}{a^{2} \cos ^{2} \varphi+b^{2} \sin ^{2} \varphi} \tag{1.8}
\end{equation*}
$$

Let :

$$
\begin{equation*}
V^{2}=\frac{a^{2} \cos ^{2} \varphi+b^{2} \sin ^{2} \varphi}{b^{2}}=1-e^{\prime 2} \cos ^{2} \varphi \tag{1.9}
\end{equation*}
$$

where $e^{\prime}$ is the second eccentricity, then:

$$
\begin{equation*}
V=\frac{\sin \varphi}{\sin \psi}=\frac{a}{b} W \tag{1.10}
\end{equation*}
$$

It follows the parametric equations of the ellipse as functions of $\varphi$ as:

$$
\begin{equation*}
X=a \cos \psi=a \frac{\cos \varphi}{W}=a \frac{\cos \varphi}{\sqrt{1-e^{2} \sin ^{2} \varphi}} \tag{1.11}
\end{equation*}
$$

$$
\begin{equation*}
Y=b \sin \psi=\frac{b \sin \varphi}{V}=\frac{b^{2} \sin \varphi}{a \sqrt{1-e^{2} \sin ^{2} \varphi}}=a\left(1-e^{2}\right) \frac{\sin \varphi}{\sqrt{1-e^{2} \sin ^{2} \varphi}} \tag{1.12}
\end{equation*}
$$

let:

$$
\begin{align*}
& X=a \frac{\cos \varphi}{\sqrt{1-e^{2} \sin ^{2} \varphi}}  \tag{1.13}\\
& Y=a\left(1-e^{2}\right) \frac{\sin \varphi}{\sqrt{1-e^{2} \sin ^{2} \varphi}}
\end{align*}
$$

### 1.2.1 Differential Relations between $\varphi$ and $\psi$

From the relation (1.5), we obtain:

$$
\begin{equation*}
\frac{d \psi}{\cos ^{2} \psi}=\frac{b d \varphi}{a \cos ^{2} \varphi} \Longrightarrow \frac{d \psi}{d \varphi}=\frac{b \cos ^{2} \psi}{a \cos ^{2} \varphi} \tag{1.14}
\end{equation*}
$$

and using (1.7), we have:

$$
\begin{equation*}
\frac{d \psi}{d \varphi}=\frac{b}{a W^{2}}=\frac{b}{a\left(1-e^{2} \sin ^{2} \varphi\right)} \tag{1.15}
\end{equation*}
$$

### 1.3 The Expression of the Calculation of the Great Normal

We call the great normal the lenght of $J M$. The vector $\boldsymbol{J} \boldsymbol{M}$ is normal to the ellipse at $M$, let $\boldsymbol{l}=\frac{\boldsymbol{J M}}{\|\boldsymbol{J} \boldsymbol{M}\|}$, its components are: $(\cos \varphi, \sin \varphi)$ (Fig. 1.4 .

Then the Cartesian equation of the normal is:

$$
\begin{equation*}
\frac{X-X_{M}}{\cos \varphi}=\frac{Y-Y_{M}}{\sin \varphi} \tag{1.16}
\end{equation*}
$$

We obtain the ordinate of $J$ in taking $X=0$ in (1.16, then:

$$
\frac{-X_{M}}{\cos \varphi}=\frac{Y-Y_{M}}{\sin \varphi} \Longrightarrow Y_{J}=Y_{M}-X_{M} \operatorname{tg} \varphi
$$

It follows the expression of the distance $M J$ equal to :

$$
M J=\sqrt{\left(Y_{J}-Y_{M}\right)^{2}+X_{M}^{2}}=\sqrt{X_{M}^{2} \operatorname{tg}^{2} \varphi+X_{M}^{2}}=X_{M} \sqrt{1+\operatorname{tg}^{2} \varphi}=\frac{X_{M}}{\cos \varphi} \frac{X_{M}}{\cos \varphi}
$$

But:

$$
X_{M}=\frac{a \cos \varphi}{W} \Longrightarrow M J=\frac{a \cos \varphi}{W \cos \varphi}=\frac{a}{W}=\frac{a}{\sqrt{1-e^{2} \sin ^{2} \varphi}}
$$

Let :

$$
\begin{equation*}
N(\varphi)=M J=\frac{a}{\sqrt{1-e^{2} \sin ^{2} \varphi}} \tag{1.17}
\end{equation*}
$$

$N$ is called the great normal.

The parametric equations of an ellipse (1.3) become:

$$
\begin{array}{r}
X=a \cos \psi=a \frac{\cos \varphi}{W}=a \frac{\cos \varphi}{\sqrt{1-e^{2} \sin ^{2} \varphi}}=N(\varphi) \cos \varphi \\
Y=b \sin \psi=b \frac{\sin \varphi}{V}=a\left(1-e^{2}\right) \frac{\sin \varphi}{\sqrt{1-e^{2} \sin ^{2} \varphi}}=\left(1-e^{2}\right) N(\varphi) \sin \varphi
\end{array}
$$

Finally:

$$
\begin{align*}
& X=a \frac{\cos \varphi}{\sqrt{1-e^{2} \sin ^{2} \varphi}}=N(\varphi) \cos \varphi \\
& Y=a\left(1-e^{2}\right) \frac{\sin \varphi}{\sqrt{1-e^{2} \sin ^{2} \varphi}}=\left(1-e^{2}\right) N(\varphi) \sin \varphi \tag{1.18}
\end{align*}
$$

### 1.3.1 Elementary arc ds and Radius of Curvature of an Ellipse

The elementary arc $d s$ of an ellipse is determined from the parametric equations as:

$$
\begin{array}{r}
d s^{2}=d X^{2}+d Y^{2}=a^{2} \sin ^{2} \psi d \psi^{2}+b^{2} \cdot \cos ^{2} \psi d \psi^{2} \\
\text { or } d s^{2}=\left(a^{2} \sin ^{2} \psi+b^{2} \cdot \cos ^{2} \psi\right) d \psi^{2}
\end{array}
$$

Using the equations 1.7) and 1.10, we obtain:

$$
d s=\frac{b}{W} \cdot d \psi
$$

Replacing $d \psi$ using (1.15), we find:

$$
d s=a\left(1-e^{2}\right) \frac{d \varphi}{\left(1-e^{2} \sin ^{2} \varphi\right)^{3 / 2}}
$$

The length of the meridian arc counted from the equator is:

$$
\begin{equation*}
s(\varphi)=\int_{0}^{\varphi} d s=a\left(1-e^{2}\right) \int_{0}^{\varphi} \frac{d t}{\left(1-e^{2} \sin ^{2} t\right)^{3 / 2}} \tag{1.19}
\end{equation*}
$$

The integration is obtained from a limited development of $\left(1-e^{2} \sin ^{2} t\right)^{-3 / 2}$ (Voir plus loin). The radius of curvature of an ellipse $\rho$ is given from $d s$ as:

$$
\begin{equation*}
\rho=\frac{d s}{d \varphi}=\frac{b^{2}}{a W^{3}}=\frac{a\left(1-e^{2}\right)}{\left(1-e^{2} \sin ^{2} \varphi\right)^{3 / 2}} \tag{1.20}
\end{equation*}
$$

### 1.4 Geometry of the Ellipsoid of Revolution

We will study the properties of the ellipsoid of revolution obtained by the rotation of an ellipse around the semi-minor axis as shown in the figure below (Fig. 1.5):

### 1.4.1 The Geographic Coordinates

The geographic coordinates defined on the ellipsoid of revolution are:

- the longitude $\lambda$ : angle of the meridian plane of point $M$ with the origin meridian plane, in our case, the origin plane is the $X O Z$ plane, - the latitude $\varphi$ : angle of the direction of the normal at point $M$ with the equatorial plane;
- the ellipsoid altitude $h e$, if the point is on the ellipsoid, then $h e=0$.

In the plane $R O Z$ (Fig. 1.6), with $\boldsymbol{r}$ and $\boldsymbol{k}$ the unit vectors of the axis $O R$ and $O Z$, we can write:

$$
\begin{array}{r}
\boldsymbol{O M}=a \cos \psi \boldsymbol{r}+b \sin \psi \boldsymbol{k} \\
\text { and } \boldsymbol{r}=\cos \lambda \boldsymbol{i}+\sin \lambda \boldsymbol{j}
\end{array}
$$

Then:

$$
\boldsymbol{O M}=a \cos \psi \cos \lambda i+a \cos \psi \sin \lambda j+b \sin \psi k
$$

It follows the parametric equations of the point $M$ are :

$$
\begin{array}{r}
X=a \cos \psi \cos \lambda \\
Y=a \cos \psi \sin \lambda \\
Z=b \sin \psi
\end{array}
$$

Replacing $\psi$ in function of $\varphi$, we obtain:

$$
\begin{array}{r}
X=a \cos \psi \cos \lambda=\frac{a \cos \varphi}{W} \cos \lambda=N \cos \varphi \cos \lambda \\
Y=a \cos \psi \sin \lambda=N \cos \varphi \sin \lambda \\
Z=b \sin \psi=\frac{b^{2} \sin \varphi}{a \sqrt{1-e^{2} \sin ^{2} \varphi}}=N\left(1-e^{2}\right) \sin \varphi
\end{array}
$$

Let :

$$
\begin{align*}
& X=N \cos \varphi \cos \lambda \\
& Y=N \cos \varphi \sin \lambda  \tag{1.21}\\
& Z=N\left(1-e^{2}\right) \sin \varphi
\end{align*}
$$

If $h e \neq 0$, then the coordinates of $M$ are:

$$
\begin{align*}
& X=(N+h e) \cos \varphi \cos \lambda \\
& Y=(N+h e) \cos \varphi \sin \lambda  \tag{1.22}\\
& Z=\left(N\left(1-e^{2}\right)+h e\right) \sin \varphi
\end{align*}
$$

### 1.4.2 Passage from three-dimensional coordinates $(X, Y, Z)$ to $(\varphi, \lambda, h e)$ coordinates

From the first two equations of $\sqrt{1.22}$ and ignoring the special case $(X=0)$, we get:

$$
\begin{equation*}
\operatorname{tg} \lambda=\frac{Y}{X} \Longrightarrow \lambda=\operatorname{Arctg} \frac{Y}{X} \tag{1.23}
\end{equation*}
$$

We denote :

$$
r=\sqrt{X^{2}+Y^{2}}=(N+h e) \cos \varphi
$$

From (1.22), can write:

$$
\begin{equation*}
Z=(N+h e) \sin \varphi-N e^{2} \sin \varphi \tag{1.24}
\end{equation*}
$$

or:

$$
Z=Z^{\prime}-N e^{2} \sin \varphi
$$

with:

$$
\begin{equation*}
Z^{\prime}=(N+h e) \sin \varphi \tag{1.25}
\end{equation*}
$$

The calculation of $\varphi$ is done by iterations:
$-1^{s t}$ iteration:

$$
\begin{equation*}
Z^{\prime}=Z \Rightarrow \operatorname{tg} \varphi=\frac{Z^{\prime}}{r} \Rightarrow \varphi_{1}=\operatorname{Arctg} \frac{Z^{\prime}}{r} \tag{1.26}
\end{equation*}
$$

$-2^{\text {nd }}$ iteration: $N=a\left(1-e^{2} \sin ^{2} \varphi_{1}\right)^{-1 / 2}, \quad Z^{\prime}=Z+N e^{2} \cdot \sin \varphi_{1}$
and : $\varphi_{2}=\operatorname{Arctg}\left(Z^{\prime} / r\right)$.
$-3^{r d}$ iteration: $N=a\left(1-e^{2} \sin ^{2} \varphi_{2}\right)^{-1 / 2} \quad Z^{\prime}=Z+N e^{2} \cdot \sin \varphi_{2}$
and : $\varphi_{3}=\operatorname{Arctg}\left(Z^{\prime} / r\right)$. In general, 3 to 4 iterations are sufficient and we obtain:

$$
\begin{equation*}
\varphi=\varphi_{3} \tag{1.27}
\end{equation*}
$$

As a result, we can determine the geodetic altitude he:

$$
\begin{equation*}
h e=\frac{r}{\cos \varphi}-N(\varphi) \tag{1.28}
\end{equation*}
$$

### 1.5 Calculation of the Geodesic Lines of the Ellipsoid of Revolution

" Alongside the main difficulty, that which lies at the very bottom of things, there are a host of secondary difficulties which further complicate the task of the researcher. It would therefore be advantageous to study first a problem where one would encounter this main difficulty, but where one would be freed from all the secondary difficulties. This problem is obvious, it is that of the geodesic lines of a surface; it is still a problem of dynamics, so that the main difficulty remains; but it is the simplest of all dynamic problems. "

## (H. Poincare ${ }^{1}$ 1905)

We define the geodesic lines of a surface then we establish the geodesic equations for a given surface. As an application, we detail those of the ellipsoid of revolution. We will integrate these equations.

### 1.5.1 Introduction and Notations

Let $(S)$ be one surface defined by the parameters $(u, v)$ with $(u, v) \in \mathscr{D}$ one domain $\subset \mathbb{R}^{2}$. One point $M \in(S)$ verifies :

& y(u, v) \\
& z(u, v)
\end{align*}
$$\right.
\]

We introduce the usual notations :

$$
\begin{align*}
& E=\frac{\partial \boldsymbol{M}}{\partial u} \cdot \frac{\partial \boldsymbol{M}}{\partial u}=\left\|\frac{\partial \boldsymbol{M}}{\partial u}\right\|^{2} \\
& F=\frac{\partial \boldsymbol{M}}{\partial u} \cdot \frac{\partial \boldsymbol{M}}{\partial v} \\
& G=\frac{\partial \boldsymbol{M}}{\partial v} \cdot \frac{\partial \boldsymbol{M}}{\partial v}=\left\|\frac{\partial \boldsymbol{M}}{\partial v}\right\|^{2} \tag{1.30}
\end{align*}
$$

From the equations (1.30), we obtain the equations:

$$
\begin{align*}
& \frac{\partial E}{\partial u}=2 \frac{\partial \boldsymbol{M}}{\partial u} \cdot \frac{\partial^{2} \boldsymbol{M}}{\partial u^{2}} \\
& \frac{\partial E}{\partial v}=2 \frac{\partial \boldsymbol{M}}{\partial u} \cdot \frac{\partial^{2} \boldsymbol{M}}{\partial u \partial v} \\
& \frac{\partial F}{\partial u}=\frac{\partial^{2} \boldsymbol{M}}{\partial u^{2}} \cdot \frac{\partial \boldsymbol{M}}{\partial v}+\frac{\partial \boldsymbol{M}}{\partial u} \cdot \frac{\partial^{2} \boldsymbol{M}}{\partial u \partial v}  \tag{1.31}\\
& \frac{\partial F}{\partial v}=\frac{\partial^{2} \boldsymbol{M}}{\partial v^{2}} \cdot \frac{\partial \boldsymbol{M}}{\partial u}+\frac{\partial \boldsymbol{M}}{\partial v} \cdot \frac{\partial^{2} \boldsymbol{M}}{\partial u \partial v} \\
& \frac{\partial G}{\partial u}=2 \frac{\partial \boldsymbol{M}}{\partial v} \cdot \frac{\partial^{2} \boldsymbol{M}}{\partial u \partial v} \\
& \frac{\partial G}{\partial v}=2 \frac{\partial \boldsymbol{M}}{\partial v} \cdot \frac{\partial^{2} \boldsymbol{M}}{\partial v^{2}}
\end{align*}
$$

Let $\boldsymbol{n}$ be the unit vector at $M(u, v)$ on the surface $(S), \boldsymbol{n}$ is given by :

$$
\begin{equation*}
n=\frac{\frac{\partial \boldsymbol{M}}{\partial u} \wedge \frac{\partial \boldsymbol{M}}{\partial u}}{H} \tag{1.32}
\end{equation*}
$$

with:

$$
\begin{equation*}
H=\left\|\frac{\partial \boldsymbol{M}}{\partial u} \wedge \frac{\partial \boldsymbol{M}}{\partial u}\right\| \tag{1.33}
\end{equation*}
$$

then :

$$
\begin{equation*}
d s^{2}=E \cdot d u^{2}+2 . F \cdot d u \cdot d v+G \cdot d v^{2} \tag{1.34}
\end{equation*}
$$

The equation 1.34 represents the square of the infinitesimal length of the arc.
Let $(\Gamma)$ be a curve traced on $(S)$ and $\boldsymbol{N}$ is the unit vector of the principal normal along $(\Gamma)$.

Definition 1.3 A curve $(\Gamma)$ is a geodesic line on the surface $(S)$ if and only if the vectors $\boldsymbol{n}$ and $\boldsymbol{N}$ are collinear.

We prove by the calculation of variations that the geodesic line between two points of a surface $(S)$ when it exists is the curve of minimum length joining the two points.

### 1.5.2 Differential Equations of Geodesic Lines

We calculate $\boldsymbol{N}$, we get :

$$
N=R \frac{d \boldsymbol{T}}{d s}
$$

but:

$$
\boldsymbol{T}=\frac{d \boldsymbol{M}}{d s}=\frac{\partial \boldsymbol{M}}{\partial u} \frac{d u}{d s}+\frac{\partial \boldsymbol{M}}{\partial v} \frac{d v}{d s}
$$

then:

$$

The condition $\boldsymbol{n} / / \boldsymbol{N}$ can be written as :

We now consider as surface the ellipsoid of revolution which we parametrize as follows:

We notice that the coefficient $k$ is greater than 1 , therefore the geodesic latitude $\varphi$ remains lower than the latitude $\varphi_{1}$ defined by $\sin \varphi_{1}=1 / k$.

\end{equation*}

Taking as variable $w=\operatorname{sint}$, the integral 1.75 becomes:

By taking $t=\sin \varphi$ as a new variable, the integral of 1.78 gives by taking as the origin of the curvilinear abscissa $s$ a point on the equator:

The integrals (1.76) and (1.79) are called elliptic integrals of the third kind.

### 1.6 Applications to Direct and Inverse Problems of the Computation of Geodesic Lines

In this second part, we will deal numerically the application of the preceding formulas in the resolution of the problems called respectively direct and inverse of the computation of the geodesic lines.

### 1.6.1 The Direct Problem

We give :

- the coordinates $\left(\varphi_{1}, \lambda_{1}\right)$ of a point $M_{1}$;
- the length $s$ of the geodesic line from $M_{1}$ to $M_{2}$;
- the geodetic azimuth $A z_{1}$ of the geodesic line from $M_{1}$ to $M_{2}$.

We ask to calcultate:

- the geodetic coordinates $\left(\varphi_{2}, \lambda_{2}\right)$ of the point $M_{2}$;
- the geodetic azimuth $A z_{2}$ at $M_{2}$.

Solution: 1. Calculate the constant $C, C=N\left(\varphi_{1}\right) \cdot \cos \varphi_{1} \cdot \sin A z_{1}=a \cdot \sin (A z e)$, then $A z e$ and $k$.
2. Determination of $\varphi_{2}$ from :

$$
\Delta s=\frac{a\left(1-e^{2}\right)}{\cos A z e} \frac{\cos \varphi_{1} \Delta \varphi}{\left(1-e^{2} \sin ^{2} \varphi_{1}\right) \sqrt{\left(1-k^{2} \sin ^{2} \varphi_{1}\right)\left(1-e^{2} \sin ^{2} \varphi_{1}\right)}}
$$

with $\Delta \varphi=\varphi_{2}-\varphi_{1}$.
3. Knowing $\varphi_{2}$, we calculate $\lambda_{2}$ using :

$$
\lambda_{2}-\lambda_{1}=\left(1-e^{2}\right) \operatorname{tg}(A z e) \int_{\sin \varphi_{1}}^{\sin \varphi_{2}} \frac{d w}{\left(1-w^{2}\right) \sqrt{\left(1-e^{2} w^{2}\right)\left(1-k^{2} w^{2}\right)}}
$$

4. Calculate $A z_{2}$ by the formula $\sin \left(A z_{2}\right)=C / r\left(\varphi_{2}\right)$.

### 1.6.2 The Inverse Problem

We give the coordinates $\left(\varphi_{1}, \lambda_{1}\right)$ and $\left(\varphi_{2}, \lambda_{2}\right)$ of two points $M_{1}$ and $M_{2}$. We ask to calculate:

- the length $s$ of the geodesic line from $M_{1}$ to $M_{2}$;
- the geodetic azimuth $A z_{1}$ at $M_{1}$;
- the geodetic azimuth $A z_{2}$ at $M_{2}$


## Solution:

1. We must calculate the constant $C$ : from the equation $\sqrt{1.69)}$, we can write :

$$
\left(\frac{\Delta \lambda}{\Delta \varphi}\right)^{2}=\frac{\rho^{2}\left(\varphi_{1}\right)}{r^{2}\left(\varphi_{1}\right)} \frac{C^{2}}{\left(r^{2}\left(\varphi_{1}\right)-C^{2}\right)}=\frac{\left(\lambda_{2}-\lambda_{1}\right)^{2}}{\left(\varphi_{2}-\varphi_{1}\right)^{2}}
$$

that gives $C$ :

C=\frac{\frac{r^{2}}{\rho} \frac{\Delta \lambda}{\Delta \varphi}}{\sqrt{1+\frac{r^{2}}{\rho^{2}}\left(\frac{\Delta \lambda}{\Delta \varphi}\right)^{2}}}
$$

Considering the azimuth between 0 and $\pi$, therefore $A z$ is positive, $C$ is positive. By calculating it for $\varphi_{1}$ and $\varphi_{2}$, we get $C$ by the mean value:

C=\frac{C_{1}\left(\varphi_{1}\right)+C_{2}\left(\varphi_{2}\right)}{2}
$$

2. Then, we obtain the value of $k$ by 1.71):

k=\frac{a^{2}-C^{2} e^{2}}{a^{2}-C^{2}}

3. Having the value of $C$, from (1.51), we obtain $A z_{1}$ and $A z_{2}$ :

\sin A z_{1}=\frac{C}{r\left(\varphi_{1}\right)} \quad \text { and } \quad \sin A z_{2}=\frac{C}{r\left(\varphi_{2}\right)}
$$

4. Then, we obtain also $A z_{e}: \sin A z_{e}=\frac{C}{a}$
5. Finally, the equation (1.79) gives $s$.

We retire the process.

### 1.6.3 Computation of the term (1.79)

In this paragraph, we calculate in detail :

$$
s=\frac{a\left(1-e^{2}\right)}{\cos A z_{e}} \int_{0}^{\sin \varphi} \frac{d t}{\left(1-e^{2} t^{2}\right) \sqrt{\left(1-k^{2} t^{2}\right)\left(1-e^{2} t^{2}\right)}}
$$

For $|x|<1$, we have the following limited developments:

$$
\begin{gather*}
\frac{1}{(1+x)^{3 / 2}}=1-\frac{3}{2} x+\frac{15}{8} x^{2}-\frac{35}{16} x^{3}+\frac{315}{128} x^{4}+\ldots  \tag{1.80}\\
\frac{1}{\sqrt{1-x}}=1+\frac{x}{2}+\frac{3 x^{2}}{8}+\frac{5 x^{3}}{16}+\frac{35 x^{4}}{128}+\ldots \tag{1.81}
\end{gather*}
$$

Taking $x=-e^{2} t^{2}$ and $x=k^{2} t^{2}$, we obtain:

$$
\begin{gather*}
\frac{1}{\left(1-e^{2} t^{2}\right)^{3 / 2}}=1+\frac{3}{2} e^{2} t^{2}+\frac{15}{8} e^{4} t^{4}+\frac{35}{16} e^{6} t^{6}+\frac{315}{128} e^{8} t^{8}+\ldots \\
\frac{1}{\sqrt{1-k^{2} t^{2}}}=1+\frac{k^{2} t^{2}}{2}+\frac{3 k^{4} t^{4}}{8}+\frac{5 k^{6} t^{6}}{16}+\frac{35 k^{8} t^{8}}{128}+\ldots \tag{1.82}
\end{gather*}
$$

Then:

$$
\begin{gather*}
\frac{1}{\left(1-e^{2} t^{2}\right) \sqrt{\left(1-k^{2} t^{2}\right)\left(1-e^{2} t^{2}\right)}}=1+\frac{k^{2}+3 e^{2}}{2} t^{2}+\frac{3 k^{4}+6 e^{2} k^{2}+15 e^{4}}{8} t^{4}+ \\
\frac{5 k^{6}+9 k^{4} e^{2}+15 k^{2} e^{4}+35 e^{6}}{16} t^{6}+\frac{35 k^{8}+60 k^{6} e^{2}+90 k^{4} e^{4}+140 k^{2} e^{6}+315 e^{8}}{128} t^{8}+\ldots \tag{1.83}
\end{gather*}
$$

or to the order 4 :

$$
\begin{equation*}
\frac{1}{\left(1-e^{2} t^{2}\right) \sqrt{\left(1-k^{2} t^{2}\right)\left(1-e^{2} t^{2}\right)}}=1+m t^{2}+n t^{4}+\ldots \tag{1.84}
\end{equation*}
$$

with:

$$
m=\frac{k^{2}+3 e^{2}}{2} ; \quad n=\frac{3 k^{4}+6 e^{2} k^{2}+15 e^{4}}{8}
$$

### 1.6.4 Calculation of the expression (1.76)

We have:

$$
\lambda-\lambda_{e}=\left(1-e^{2}\right) \operatorname{tg}(A z e) \int_{0}^{\sin \varphi} \frac{d w}{\left(1-w^{2}\right) \sqrt{\left(1-e^{2} w^{2}\right)\left(1-k^{2} w^{2}\right)}}
$$

that becomes in our case:

$$
\lambda_{2}-\lambda_{1}=\left(1-e^{2}\right) \operatorname{tg}(A z e) \int_{\sin \varphi_{1}}^{\sin \varphi_{2}} \frac{d t}{\left(1-t^{2}\right) \sqrt{\left(1-e^{2} t^{2}\right)\left(1-k^{2} t^{2}\right)}}
$$

But from (1.81):

$$
\frac{1}{\sqrt{1-e^{2} t^{2}}}=1+\frac{1}{2} e^{2} t^{2}+\frac{3}{8} e^{4} t^{4}+\frac{5}{16} e^{6} t^{6}+\frac{35}{128} e^{8} t^{8}+\ldots
$$

and :

$$
\frac{1}{\sqrt{1-k^{2} t^{2}}}=1+\frac{k^{2} t^{2}}{2}+\frac{3 k^{4} t^{4}}{8}+\frac{5 k^{6} t^{6}}{16}+\frac{35 k^{8} t^{8}}{128}+\ldots
$$

and for $\left(1-t^{2}\right)^{-1}$, we obtain:

$$
\frac{1}{1-t^{2}}=1+t^{2}+t^{4}+t^{6}+t^{8}+\ldots
$$

Then :

$$
\begin{gathered}
\frac{1}{\left(1-t^{2}\right) \sqrt{\left(1-e^{2} t^{2}\right)\left(1-k^{2} t^{2}\right)}}=1+\frac{2+k^{2}+e^{2}}{2} t^{2}+ \\
\frac{8+4 k^{2}+4 e^{2}+3 k^{4}+2 e^{2} k^{2}+3 e^{4}}{8} t^{4}+ \\
\frac{16+8 k^{2}+8 e^{2}+6 k^{4}+4 e^{2} k^{2}+6 e^{4}+5 k^{6}+3 k^{4} e^{2}+3 k^{2} e^{4}+5 e^{6}}{16} t^{6}+\ldots
\end{gathered}
$$

that we write under the form:

$$
\begin{equation*}
\frac{1}{\left(1-t^{2}\right) \sqrt{\left(1-e^{2} t^{2}\right)\left(1-k^{2} t^{2}\right)}}=1+\alpha t^{2}+\beta t^{4}+\gamma t^{6}+\ldots \tag{1.85}
\end{equation*}
$$

with:

$$
\left\{\begin{array}{l}
\alpha=\frac{2+k^{2}+e^{2}}{2}  \tag{1.86}\\
\beta=\frac{8+4 k^{2}+4 e^{2}+3 k^{4}+2 e^{2} k^{2}+3 e^{4}}{8} \\
\gamma=\frac{16+8 k^{2}+8 e^{2}+6 k^{4}+4 e^{2} k^{2}+6 e^{4}+5 k^{6}+3 k^{4} e^{2}+3 k^{2} e^{4}+5 e^{6}}{16}
\end{array}\right.
$$
