II. PROCESS MODEL




Fig. 1 Process Model

In this model, the sequence of activities performed in a software development project are: -


- 1. Requirement Analysis




Fig. 3 First Level DFD

C. Second Level Data flow Diagram (2 Level DFD) of Digital Bookstore -




Fig. 4 Second Level DFD


A. Purpose of Class Diagram -

CLASS DIAGRAM OF DIGITAL BOOKSTORE


Fig. 5 Class Diagram





Fig. 7 Collaboration Diagram




Fig. 9 Activity Diagram

- 2. It does not show the order in which steps are performed to achieve the goals of each use case.




Fig. 11 Use Case Diagram




Fig. 12 Flow Graph
